**Subject: Participation of Para Powerlifting Athletes in Beijing 2025 World Cup on Self-Financing Basis.**

Dear All,

The Paralympic Committee of India (PCI) is committed to providing more competitive exposure and ranking opportunities to our para-athletes in view of the upcoming **Los Angeles 2028 Paralympic Games**.

In this context, athletes who secured **1st, 2nd, and 3rd positions** in the following events:

- **National Para Powerlifting Championship**, held at Greater Noida from **16th to 18th March 2025**
- **Khelo India Para Games**, held at New Delhi from **21st to 27th March 2025**

and **do not currently fall within the Top 8 of the Asian Rankings** as per the latest WPPO data, are permitted to participate in the upcoming **Beijing 2025 Para Powerlifting World Cup** scheduled from **17th to 25th June 2025** in Beijing, China on self-financing basis.

This opportunity is being extended as part of PCI's broader vision to enable greater access to international events, with the goal of improving individual world rankings in the new Paralympic qualification cycle.

### **Cost & Payment Details**

Athletes willing to participate on self-financing basis are required to submit an **amount of INR 3,00,000 (Three Lakhs only)** towards the approximate cost of **airfare, accommodation, visa, insurance, and local transport**. This is an estimated figure and is subject to actual expenditure. Any excess amount, if applicable, will be refunded to the concerned athlete after final settlement.

### **Action Required**

Interested athletes are advised to submit the following on or before **10<sup>th</sup> May 2025** at **17:00hrs** as this is also the last date to submit the entries to WPPO.

1. **Consent for participation**
2. **Passport copy (valid for at least 6 months)**
3. **Proof of National/ Khelo India Medal Position**
4. **Payment of INR 3,00,000 via NEFT/RTGS**
